

# Investments are Paying Off: 20% Growth in Sales Volume and Strong Expansion in Value-Added Products

2025 first half was marked by overall weakness in the global steel market and a contraction in both production and demand in Türkiye's domestic market. Despite these challenges, Kocaer Çelik increased its total sales volume by 19.7% compared to the same period of last year, reaching 314,155 tons in the first half of 2025.

Thanks to its strategy of focusing on value-added product manufacturing, the share of these products in total sales rose from 38% in the same period last year to 47%. This ratio stood at 42% for the full year 2024. Leveraging its broad portfolio and global reach with a sales network spanning six continents, the company generated 78% of its sales from international markets, recording net revenue of TRY 10.515 billion in the first half of 2025.

# Strong Operational Performance with TRY 1.5 Billion EBITDA in the First Half Despite Challenging Conditions

Despite the high tariffs imposed by the U.S. on steel imports and the dollar-based decline in global steel prices creating volatile market conditions, Kocaer Çelik managed to strengthen its operational profitability. In the first half of 2025, gross profit increased by 12% year-on-year to TRY 2.16 billion, while operating profit rose by 42% to TRY 1.24 billion.

Key factors in maintaining profitability included the rising share of high value-added products in total sales, the commissioning of modernization investments in factories, a broad and niche product portfolio, and the ability to create alternative markets across different geographies. During this period, adjusted EBITDA grew by 8% to TRY 1.50 billion. Despite challenges and price pressures in the global market, Kocaer Çelik generated TRY 693 million EBITDA in the first quarter and increased this figure to TRY 807 million in the second quarter, maintaining a 14% EBITDA margin in both quarters—demonstrating its operational efficiency.

By managing global fluctuations with new achievements in alternative markets, the company increased its net profit by 101% year-on-year in the first half of 2025, reaching TRY 389 million.



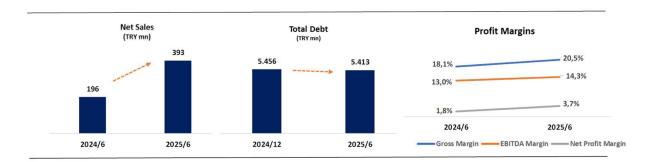
## INVESTOR SUMMARY NOTE 01 JANUARY – 30 JUNE 2025



### Indebtedness Declines While Profit Margins Improve Significantly Year-on-Year

Following the completion of revision works and new machinery investments over the past two years, the investment needs in two of the three steel profile factories in Aliağa have decreased. Accordingly, in the first half of 2025, capital expenditures—excluding the energy segment—declined by 36% year-on-year to TRY 203.2 million.

As a result of reduced capital expenditures and disciplined working capital management, total financial debt decreased by 1% compared to year-end 2024, standing at TRY 5,413 million as of June 30, 2025. Thanks to effective finance management, the net financial debt-to-EBITDA ratio was maintained at 1.1x, reflecting a strong financial position.
